REGULATION

1. The "Mario Lanza Legend International Singing Competition", on the centenary of the birth of the Italian-American tenor Mario Lanza, is open to all singers, opera and pop music, **to all voices, male and female**, provided they are adults, of any nationality, **without age limits**.
 2. Together with the registration form, the candidate must submit:
 - a) a short one-page curriculum vitae with telephone numbers and email address;
 - b) **an MP4 video with a romanza of your choice, performed with piano accompaniment, to be sent by 30 June 2021 for pre-selection;**
 - c) if the preselection is passed, the singer have to send a **second MP4 video** with a romance of his choice to be sent **by 31 July 2021;**
 - d) receipt of **payment of € 50.00**, Reason: registration fee for the Lanza Competition, addressed a: Associazione Parma OperArt c/o Banca Intesa Sanpaolo, filiale 55000 di Milano, Italy.

In case of non-participation in the contest, the secretariat is not required, under any circumstances, to refund the registration fee.
3. The **deadline for registration** and receipt of all documentation is set for **30 June 2021**.
 4. **The first phase of the competition - Preliminary Auditions - consists in the evaluation of the candidate's MP4 video and his CV, to be sent by 30 June 2021.** Candidates who move on to the second round of the selection will be notified by email and they must send a **second MP4 video by 31 July 2021**.
 5. **The 8 singers who will move to the final will be notified by 20 August.** The eight finalists will perform a concert at the Casa della Musica in Parma **on 20 September 2021**, with piano accompaniment only. **As part of the final concert, the "Mario Lanza Legend" prize will be awarded.**
 6. **Repertoire required.** Participants can bring to the competition romances or songs related to:
 - a) Opera repertoire;
 - b) Neapolitan song;
 - c) Songs from Mario Lanza's repertoire.

7. The finalist singers will be hosted in the hotel in Parma at the expense of the organization. Travel costs are in charge to the finalist singers. The singer who will win the "**Mario Lanza Legend**" prize will receive a prize-plaque and a cash prize worth € 500.00 =
